

PRESIDENT'S MESSAGE by Lyn Van Druff

Welcome to the Beginning of Summer 2020!

An unusual summer to be sure, but I'm confident that with careful measures, we can still enjoy the beauty of our beloved Adirondacks. LPSA has been working over the winter on several fronts to advance the agenda of protecting our lakes and beautifying our town.

We continue to have Lake Stewards at both Moffitt Beach ramp on Sacandaga and at the Pavilion ramp on Lake Pleasant. Adirondack Watershed Institute (AWI) will be providing stewards Thursday through Monday this year. LPSA is working on adding stewards for Tuesday and Wednesday.

The DECON free Boat Wash is located on the northbound lane of Rt. 30 just before Speculator. Please use the Free Boat Wash on your personal craft, and encourage all guests to stop with their craft on their way into town. This is an added layer of protection for our lakes.

We will be distributing newly developed info cards and refrigerator magnets to help in the mitigation the 'Nutrient Loading' that is taking place in our lakes and causing a significant growth in unwanted weeds.

Our JUNE Luncheon has been CANCELED due to COVID-19. We will however, have the information that was to be presented by Caitlin Stewart on the ways we can plant buffers on our properties to protect lakes, streams, and rivers, against damaging road and lawn

runoff. We will be sending an email blast when that presentation is available.

Lastly, as many of our members travel to Speculator/ Lake Pleasant this summer, we ask that you give special attention to the needs of the community. Hamilton County has been extremely fortunate to have been relatively free from the devastation of COVID-19. We want to be sure that continues to be the case. Please remember that Hamilton County has a very high percentage of residents over 65, the most vulnerable population for severe complications. We have very limited healthcare services and Not One pharmacy in the county! So, with that understanding, we ask that when you come to town:

- 1) Bring at least 14 days of food, medicine, and household materials
- 2) During those first 14 days, please don't go into town stores, PO, Bank, etc.
- 3) Limit your interaction with neighbors using "social distancing" and wear a mask.

If we take this extra care in the beginning, we stand a good chance of not, unknowingly, bringing any viruses with us and therefore giving everyone a healthy and happy summer.

I'm looking forward to seeing each of you this summer. Hopefully we will be able to have our August luncheon and Annual Meeting. We will keep you informed. Stay Safe and Enjoy Life!

LAKE MAPPING PROJECT

Concerns about native aquatic plant growth in Lake Pleasant in the past two years have been brought before the LPSA board. Although anecdotal, there seemed to be enough reports to warrant a study - something which might develop data so that if remediation became required at some time in the future, we would have baseline data as a starting point for discussions and action planning. Peter Tobiesen and several board members started a conventional assessment using observation of weed beds from surface craft with GPS location mapping. A map was prepared using this data. This effort may be ongoing to improve it in summer months to come.

A bit of further research indicated a company offering a system for mapping weed beds called BioBase. It turned out that DEC and APIPP were currently using it to map invasive aquatic plant beds in Adirondack lakes. Several board members attended an annual seminar at Paul Smith's College where APIPP's Ms. Erin Vennie-Vollrath made a presentation on how the software and equipment system worked and the maps it produced. We became interested.

The BioBase software displays three different views of the lake data, including a view of the density of subsurface weeds. Pricing is based on lake surface area. Lake Pleasant would cost about \$1997 for a complete single year mapping license. There were several pricing options, including one allowing unrestricted access for a single year at \$2700. We applied for a free trial license, which allowed limited views of the lake data. Ms. Vennie-Vollrath volunteered to help us with a loan of APIPP's equipment, plus training on its operation. Lowrance "fish finder" sonar equipment, a

memory card, and battery power are required for data gathering. Pricing for a portable transducer is in the range of \$600 to \$800. If LPSA decides to proceed with additional BioBase mapping, it would require access to the BioBase web page (\$1997 per year), plus C-Map software. A subscription to C-Map is required at about \$200/month, so the project would not be cheap.

Erin Vennie-Vollrath came to Lake Pleasant with gear for a training run on the lake. Mark Donecker volunteered his pontoon boat and his time. He attached the equipment to his pontoon boat and patiently made 10 runs around Lake Pleasant in ever decreasing circles, attempting to map weed beds from shoreline to about 16 feet maximum depth. Data was recorded on a memory chip and subsequently downloaded to the BioBase web page. Charlie Ascher managed this task, which was nontrivial.

Weed beds appear in differing colors on the map, indicating depth. There is no indication of taxonomy (what type of plant is present). Other users of this system at other lakes have sampled their weed beds using throw rakes or divers to indicate weed types on their maps. As we have no invasive plants in Lake Pleasant and are only interested in native pond weed populations, identification was not attempted. Discussions on whether to proceed with BioBase and/or the simpler conventional mapping techniques are ongoing. Research on techniques for limiting weed beds will be ongoing this summer as well. Many thanks to Ms. Vennie-Vollrath at APIPP for training and equipment loan and to Mark Donecker and Charlie Ascher for the mapping runs and enabling the downloads.
