#### LPSA SPONSORS FIELD TRIP FOR LOCAL STUDENTS

LPSA sponsored a field trip to the Wild Center in

Tupper Lake for the Lake Pleasant School grades 7 & 8 on May 21. The planning of this trip was integral part of the 2024 LPSA sponsored



program, which focused on Terrestrial Invasive Species this year. The program includes a required detailed research and subsequent oral presentation of the results to faculty, as well



review panel. Seventeen students and five teachers went to the Wild Center on a bus provided by the school, along

with representatives of LPSA.

While at the Wild Center, all students participated in a specially designed program which dovetailed perfectly with the subject of terrestrial invasive species. During an orientation conducted in the Theater with the updated video sphere the students were introduced to the concept of climate change and its effects on the creatures of the Adirondacks and explored the various solutions to the problem. This was

followed by time to explore the museum which students the took full advantage of.

After time for lunch under the tent on the patio, everyone went on a guided walk along the various paths



on the Center's grounds. This walk was conducted by a staff member of the Center who made sure to point out and discuss various invasive species that are already in the Adirondacks as well as those that may soon show up here. This part of the tour was a two-way discussion with the kids actively participating with targeted questions. At the conclusion of the tour, the kids had time to explore the Wild Walk, including the gigantic spider web and a simulation of a 10-

foot wide eagle's nest.

The entire day was wonderful thanks to perfect weather and the extra efforts of the Wild Center School program staff to work with the LPSA personnel to modify their presentations.



Later in the spring, the students gave their presentations to the LPSA panel. The winners of the research and presentation contest were announced at a school awards ceremony at the end of the school year.

#### **BOAT RAMP STEWARDS PROTECT OUR LAKES**

Each summer, a team of more than 100 Lake Stewards inspects boats at launch ramps in the Adirondacks to ensure that invasive plants and animals do not get introduced into our lakes. Funding for this activity is provided by New York State Dept. of Environmental Conservation (DEC). The program is administered by the Adirondack Watershed Institute (AWI) at Paul Smith's College, in the Adirondack Park.

AWI stewards also operate boat wash stations

at a number of locations to provide free boat wash service for boats and trailers to remove any invasive species. Also, CAMP-of-the-WOODS assigns members of their staff to inspect all boats being launched at their boat ramp.

To supplement the efforts of those workers, the Town

of Lake Pleasant and LPSA provide additional funding to hire part-time Lake Stewards to monitor local boat ramps on days when the AWI employees are not onduty. This summer, Bob Hogan, Jennalee Smith, and Raymond MsImanga helped provide important monitoring of boats being launched at Moffitt Beach, Spec-

ulator Pavilion, and Lake Pleasant Marine. Collectively, the Lake Stewards at these locations in our local area inspected over 2,000 boats. Membership fees and donations from LPSA members provide the funding for our Lake Stewards.




#### MEET YOUR NEW BOARD MEMBERS

This year, Charlie Ascher and Lyn Van Druff retired from our Board of Directors, after serving more than ten years as LPSA directors. We wish all the best to those Directors who are leaving us this year, and we welcome our new Directors:

#### **RON UVA**

Ron Uva was an LPSA director from 2018 through 2022. He left the Board for a few years, and has returned to serve again on our Board of Directors. He is a retired obstetrician/gynecologist having practiced in Oswego for almost 40 years. He has been coming to Speculator since getting married to his wife Sarah in 1971. Her family had built a camp on South Shore Road in 1967. Ron reports that he instantly fell in love with the Adirondacks. After a camp renovation in 2006 he and Sarah decided to make Speculator their principal residence upon retirement in 2013. They split their time between Speculator and St. Croix in the United States Virgin Islands.

Ron majored in biology at the University at Buffalo with a heavy concentration in chemistry and limnology (lake ecology) before entering medical school. ## Lake Pleasant-Sacandaga Association Annual Meeting By Tom Rippere

The Lake Pleasant – Sacandaga Association (LPSA) held its Annual Meeting and a barbeque dinner on August 25, in Speculator. Caitlin Stewart, District Manager of Hamilton County Soil and Water Conservation District (HCSWCD) gave an informative presentation on the education program sponsored jointly by HCSWCD and LPSA, which has provided classroom training and field site training in the past three years for 4<sup>th</sup>, 5<sup>th</sup>, and 6<sup>th</sup> grade students at Lake Pleasant Central School on the lake ecology topic of erosion. Students learned about the causes of erosion, the impacts of erosion, and steps that can be taken to minimize erosion. Caitlin thanked LPSA for their financial contributions to support this educational program. As a representative of HCSWCD, Caitlin is one of the Community Partners who is a member of the LPSA Board of Directors.

Dan Wilt, LPSA President, asked each committee chairperson to give a report on the activities and accomplishments of their committees over the past year. The following committees provided reports:

#### Ramp Stewards

New York State Department of Environmental Conservation (DEC) provides funding each year for more than 100 Lake Stewards to monitor boat ramps throughout the Adirondack Park during summer months. These stewards inspect boats prior to launching to ensure the boats and trailers are not carrying any invasive species that might be introduced into local lakes. DEC also provides funding for Lake Stewards who operate boat decontamination stations throughout the Adirondacks to provide free boat washes to remove any potential invasive species. Each summer, the Town of Lake Pleasant and LPSA provide funds to hire parttime Lake Stewards to monitor the boat ramps at Moffitt Beach and the Speculator Pavilion on the two days each week when the DEC-funded stewards are not on duty. A Lake Steward was also hired to monitor the boat ramp at Lake Pleasant Marine on weekends. These stewards help to keep our lakes clean and healthy.

#### Water Quality and Lake Ecology

LPSA volunteers collect lake water samples throughout the summer months for chemical analysis, through the New York State CSLAP program (Citizens' Statewide Lake Assessment Program). This summer samples were collected from both Sacandaga Lake and Echo Lake. This is the first year Echo Lake has been included in this lake data collection program.

Brian Greene, Aquatic Invasive Species Coordinator with the Adirondack Park Invasive Plant Program (APIPP), has again offered to perform an annual professional survey of lakes in the Town of Lake Pleasant to look for any invasive species, at no charge. He will be conducting a survey of Lake Pleasant this year.

#### ANNUAL MEETING Continued

#### **Education**

LPSA sponsored a research project and a field trip for 7<sup>th</sup> and 8<sup>th</sup> grade students at Lake Pleasant Central School. LPSA provided cash awards to students who won the research and presentation contest. This year, the students visited The Wild Center in Tupper Lake. The museum was open just for this group, and the staff provided a presentation customized for this student group.

LPSA also partners with HCSWCD to present classroom training and field site education for students in 4<sup>th</sup>, 5<sup>th</sup>, and 6<sup>th</sup> grade on erosion and how it affects water ecology.

#### Lake Management Plan

A committee is creating a Lake Management Plan for Lake Pleasant, Sacandaga Lake, and Echo Lake. The plan will contain detailed information on the chemistry and health of each lake and will provide plans for how we can respond in the future to any threats or problems that may develop in these lakes. Having a Lake Management Plan is often a requirement in applying for grant money in the future.

#### **Communication**

LPSA continues to provide information to our members via email, our website (LPSA-NY.org), and our FaceBook page (LPSA2016). Members and friends are invited to view the website and FaceBook page for more information.

#### **Nominating Committee**

Recognition was provided for two board members who are retiring from the board this year, after more than ten years of volunteer service. Charlie Ascher and Lyn Van Druff are both past-presidents of LPSA, and have made significant contributions to LPSA through the years. Recognition was also given to Mitzi Fox, another past-president, who retired from the board last year, after more than ten years of service.

Two candidates were nominated and elected to become new directors this year: Ron Uva and Mike Camoin.

#### <u> Lake Pleasant – Sacandaga Foundation</u>

The Lake Pleasant – Sacandaga Foundation (LPSF) is a non-profit 501(c)(3) organization that was created so that members can make tax-deductible contributions to LPSA. Funds are held in two accounts. The LPSF General Fund is used to cover a portion of LPSA's annual expenses. The LPSF Kathy Huber Memorial Fund provides a source of funding in case an invasive species is discovered in our lakes. This "disaster fund" would have funds available to enable us to respond quickly to the discovery of an invasive species, with the hope that we could eradicate it before it becomes firmly established in our lakes.

We have intentionally kept our membership fees low, to make it easy for new members to join our organization. However, our membership fees cover only about half of our annual expenses. When members renew their membership, they are encouraged to also make a donation to help support our organization. If members do make a donation, they should specify whether they want the extra money to go to the LPSF General Fund or the LPSF Kathy Huber Fund.


